

## INSTALLATION NOTES

---

1. The buyer is responsible for providing trained and experienced installation decision making with technical know-how to apply professional judgment that specifically applies to each individual installation.
2. Be sure to read and understand all available information including but not limited to instructions, warnings, sales terms, and warranties for the vehicle and all system components prior to attempting installation.
3. Disconnect the battery and drain engine coolant enough to remove the upper radiator hose without losing coolant. Remove the upper radiator hose at the engine. Using a 1/2" ratchet or other suitable tool, depress the tensioner and remove the serpentine belt. Remove the OEM idler from location A. It will be reused. Remove the bolts at locations C, D, and E. Install bracket (1) onto the engine using bolts (4) at locations C, D, and E. (Do not tighten) Install brace (2) with bolt (6) at location B, and bolts (5) into bracket (1). With all bolts installed finger tight, torque bolts (4) to 25 ft. lbs. Then torque bolt (6) to 40 ft. lbs. and bolts (5) to 25 ft. lbs.

**NOTE: On vehicles with black composite valve covers, it will be necessary to trim some plastic from the lower front portion of the valve cover for belt clearance.**

4. Disconnect the engine fan wire and remove the plastic wire support.
5. Remove bolts from locations F, G, and H. Install stud (15) at location H. Then, install idler bracket (14) using bolts (16) at locations F and G, install coupler nut (19) at location H. Install the O.E.M. idler that was removed onto bracket (14) using bushing (17) and bolt (18). Install idler (8) at location A with bolt (10) and washer (9). Install belt guard (3) with bolts (7). Do not tighten at this time. Install the pump onto the bracket (1) with bolts (12) and lock washers (13). Reinstall radio noise suppressor to top of bracket with bolt (7). Align both sides of clutch with the drive pulley using a good quality straight edge and then tighten bolts (12). Install the belt (11) as shown in the belt routing diagram. Adjust the belt guard (3) to obtain 1/8" to 1/4" clearance then tighten bolts (7). Connect the fan wire, and install the new fan wire support (20) with bolt (21) at location H. The grommet will need to be removed from the OE wire support and installed into the new wire support (20).
6. Install the upper radiator hose extension (23) using O.E.M. hose clamp onto the thermostat housing. Then, install the upper radiator hose onto it using coupler (22) and hose clamps (24).
7. Replace the engine coolant and connect the battery. Make certain all wires and hoses disturbed during installation do not come in contact with any hot or moving parts. Run the engine and check for proper belt tracking.

**CAUTION:** Before starting the engine, check to make certain no wires, hoses, etc. that may have been disturbed during installation do not come in contact with any hot or moving parts. Run the engine and check for proper belt tracking, adjust if necessary.

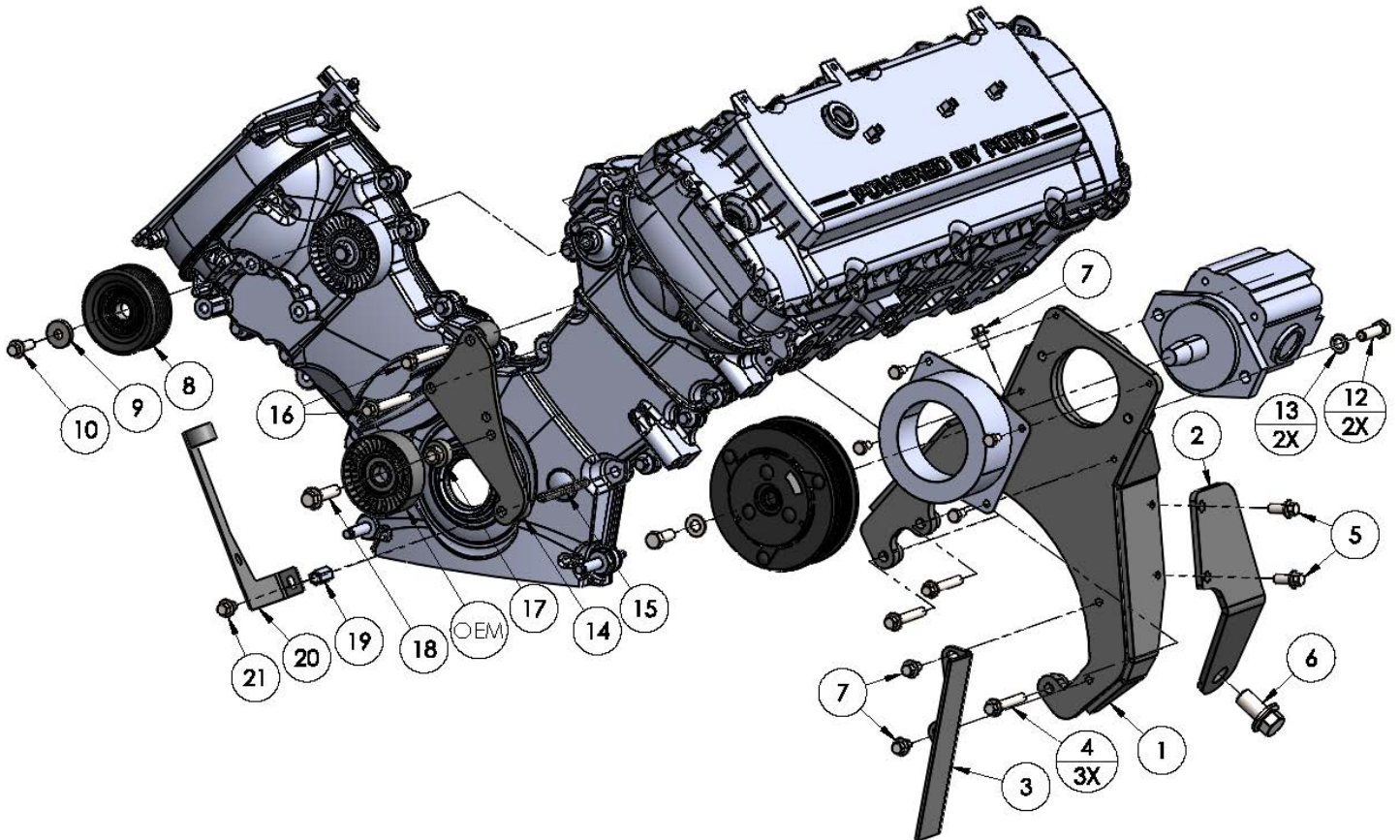

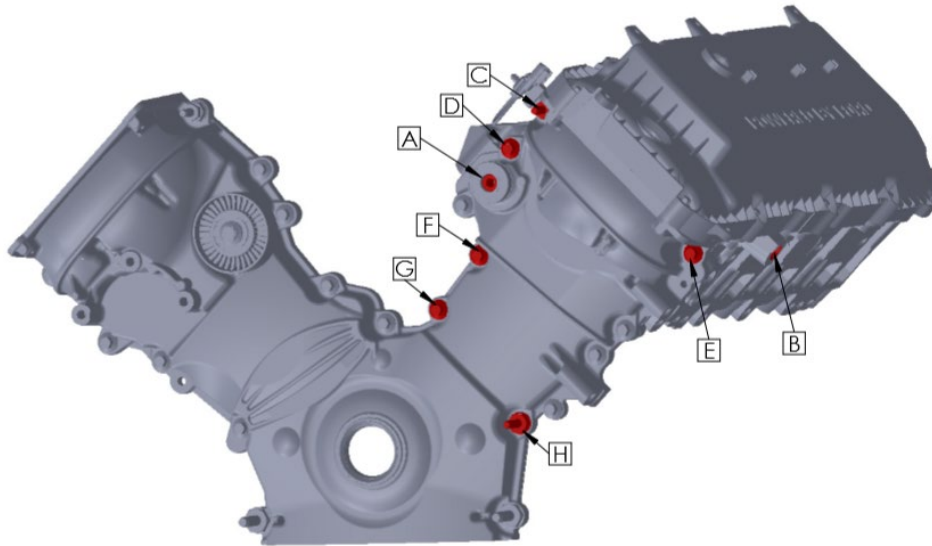
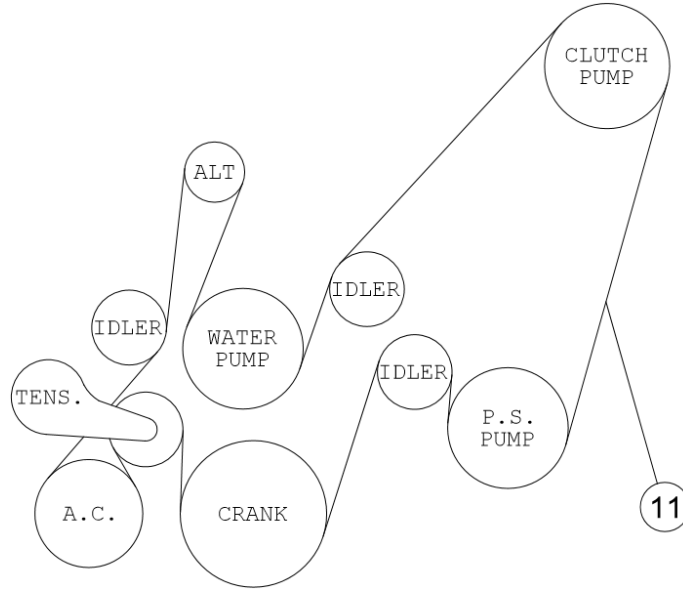
